Unresolved Items from Previous Minutes / Clerk's Update

a. Doncaster Highways is now adamant that there is nothing else that can be done to amend Lords Head Lane – The Parish Council is still pressing for more revisions than merely a speed restriction but there is little more that can be done immediately – **REMOVE**

- Root problem from Holiday Inn Trees Cllr Pattison is to request another meeting The Arboreal team at Doncaster Council have stated that there is little they can do as this is a matter between the Holiday Inn and the Parish Council – <u>ONGOING</u>
- c. Signage and Dog Fouling Further signs have been ordered and are awaiting delivery ONGOING
- d. Police Presence in Warmsworth Clerk to ask again about the possibility of police have a small "base" at the Hub - ONGOING
- e. Smokers discarded Tabs it was mentioned that these get everywhere the Clerk will order a new box for discarded tabs and designate an approved smoking area. Box order has been placed signage with it stating smoking area will, be ordered when Rob places box fitting on his schedule– a new 1st aid box is also required for the Centre REMOVE
- f. Blocked culverts KGF After meetings on site with two identified contractors and advice from both Rotherham and Doncaster Councils a suitable quote has been identified it was approved a date for the work to be done will be agreed with the contractor **ONGOING**

<u>RESOLVED</u>: After an evaluation and recommendation by the Clerk an identified contractor will unblock the culvert on a date to be advised - <u>ONGOING</u>

- g. Doncaster Council "ordering" tree outside Hub to be trimmed back Cllr Maxey has been dealing with this one a suitable reply has yet to be received **ONGOING**
- h. Bees and droppings fouling properties next to Allotment Beekeepers on the allotments have been warned that there may have to be a change to how many hives they can keep and where they can be located – Clerk is awaiting guidance from the Allotment Holders Association and the Beekeepers Association - ONGOING
- i. Remembrance and establishment of a sub-committee meeting was held before Christmas for interested parties there is to be an establishment of a Committee of Councillors and residents to co-ordinate the Remembrance Commemoration in future years and will meet probably now sometime in March It was also agreed to look at more poppies on lampposts and the Clerk reported that the scheme last year took around £135 and nearly covered the cost of the poppies £150 ONGOING
- j. Grosvenor Crescent cars parking on grass still some way to go over signs with disagreement between tow Doncaster Council Departments - in the meantime, the Parish Council has distributed open letters to all residents which has received a very positive response but there are a few residents who are still not respecting the green, fencing is not an option - <u>ONGOING</u>
